- b. Discussion re what BIVC should pay for and what islanders should pay for "pay as you throw"
 - 1) Included discussion re different volumes of debris and enforcement
 - 2) Example: Future discussions should include (but not limited to) who pays for: trash, brush, outhouse waste, construction debris, shingles, metal, chips, logs
- c. A 2008 well schedule is being prepared for submission to the state. Also wells should be tested before Memorial Day weekend. CJ will contact Laura.

- 2) **ACTION: A motion was made** (DeBruyn), seconded (LaFleur), and passed unanimously to appoint Fred Bohen to the Finance Committee starting immediately thru 2010.
- c. Clam Flats Roger and Lorraine Leland researched
 - 1) Lorraine was told by Freeport that the Bustins flats were closed. Augusta has to inspect and declare safe. Won't be done until someone from Augusta inspects.
 - 2) Reminder: You must have a license to clam, to lobster, and to crab. Not sure about mussels.
- d. Secretary needs a copy of the Finance Committee's Mission Statement for the file
- e. Road and shore work: Charlie reported that he rec'd site plan from Ross Cudlitz on 3/5/08 and Scott is seeking estimates for shoreline work. Also seeking estimates on road work
 - 1) Discussion re winter road closing
 - 2) Rec'd from RL an article featured in 2/17/08 Boston Sunday Globe on *Private ways*, *Public Access*
 - 3) **ACTION:** A motion was made (Leland), seconded (DeBruyn), and passed unanimously to start process of closing roads in accordance with state of ME Title 23 § 2953. Plan to hold a public hearing on Friday, July 4, 3:00 PM, at the Community House. Will also discuss proposed By-Law changes at this time.
- f. By-Laws: Seasonality discussion re declaration of "seasonality" for the purpose of municipal services and meetings. Craft language to open all meetings re seasonality with a statement "in as much as ..." Might even be a By-Law or Article.
- g. By-Laws: Enforcement discussion. By-Laws review committee is looking at options and researching other islands and how they handle enforcement issues.

Outlined 3 job tasks in Secretary's job description for clarity: 1) Minutes & distribution of same, 2) Broadcast Email list maintenance, and 3) Web/upload (not maintenance). Tony and Diane will work together to tweak current Web site to make it more user friendly. Diane volunteered to continue to maintain Broadcast email list and will continue to do Web uploads of BIVC approved PDF documents.
