# BUSTINS ISLAND VILLAGE CORPORATION Meeting of the Board of Overseers July 9, 2017 – 9:00 AM Approved August 6, 2017

The Board of Overseers met at 9:00 AM at the Brewer Cottage, Bustins Island, ME on Sunday, July 9, 2017. ### **MINUTES**

<u>Aquifer Protection Ordinance</u> – Carol White discussed the need to set in writing the protections for the Bustins Island aquifer especially the quality of the water. After much discussion from the floor, Board Chairman Rob Boone stated that this ordinance was a living document and would be amended as conditions change or new information comes to light. The Board felt this was an important issue and worthy of consideration now.

<u>Retail Marijuana Prohibition Ordinance</u> – Not much discussion on this ordinance. The Board wanted the BIVC to adopt the ordinance offered by the Maine Municipal Association.

<u>Tennis Court Issue</u> – The Board understands the need for the tennis courts to be maintained. Chris Martens has done much work over the years to maintain the courts and could use some help. Rob Boone stated that the Board does not want to manage the tennis courts. Some members of the audience volunteered their assistance. It was suggested that a notice be posted on the store porch wall to get more volunteers to help maintain the courts.
