Recording of the meeting was started.

1. Community House Batteries

After reviewing proposals, on a motion made and seconded it was VOTED 5-0 by roll call vote to retain Assured Solar Energy to install 12 Rolls S2-L16 batteries at the Community House at a cost of \$6250.

2. Large Equipment Permits

On a motion made and seconded it was VOTED 5-0 by roll call vote to approve the large equipment permit application as submitted by Ron Tozier. On a motion made and seconded it was VOTED 5-0 by roll call vote to approve the large equipment permit application as submitted by Rob Taisey for Assured Solar Energy.

3. Lilly B. Protocols and Freight Proposal

In accordance with the July 10, 2021 federal CDC guidelines, passenger capacity on the Lilly B. will increase to 25, with no distancing or masks required. Those not fully vaccinated should wear a mask and social distance, although it not a requirement on the boat.
