Meeting of the Board of Overseers November 13, 2021 Approved December 4, 2021

The Board of Overseers met at 10:01AM via Zoom and at the Freeport Community Library, Freeport, ME on Saturday, November 13, 2021. Overseers present were: Hank Rauch, Chair; Amanda Meyer, Vice-Chair; Tanya Sweatt, and Judy Hayes. Other officers/appointees/ contractors present were Sue Spalding, Clerk; Tony DeBruyn, Treasurer; Crawford and Candy Taisey, Straight Edge Construction (Superintendent). 3 people attended in person.

- 1. Recording of the meeting was started.
- 2. MINUTES. On a motion made and seconded it was VOTED 3-0 via roll call vote to approve the minutes of the October 16, 2021 Board of Overseers meeting. On a motion made and seconded it was VOTED 3-0 via roll call vote to approve the minutes of the November 4, 2021 Board of Overseers meeting, as amended
- 3. PUBLIC COMMENT- Bailey Coffin Aquaculture Lease

Ten islanders and interested parties expressed their opinions and concerns about the Bailey Coffin Aquaculture Lease. All supported the idea of aquaculture, but expressed concern about obstruction of navigation in this location, noise and lights and their affect on wildlife and island ambiance, size of project compared to smaller projects in the bay, and inaccuracies on the application to DMR. One warned against NIMBY mentality.

On a motion made and seconded it was VOTED 4-0 via roll call vote to engage legal counsel on how best to proceed, and to speak to DMR about correcting the misinformation on the application.
