Managing the island has become much more complex, and the availability of suitable volunteers has diminished as the island demographic has changed. Sue and Tony submitted lists of the duties they perform, and the lists were very long. In order to consider alternative ways of covering these jobs Sue, Tony, and Crawford were asked to break down their jobs into smaller categories, which might be able to be spread out to additional folks. Without that, the possible necessity of hiring people to do some of the work was brought up, as well as several other possible models. We may need to improve the island communication infrastructure to make all these parts work.

The discussion will continue at the next meeting as we consider the reorganized task sheets and how to train new people. **b. Any other new business** – None.
