# Meeting of the Board of Overseers March 14, 2020 – 10:00 AM Approved April 4, 2020

Note: The USA is currently under a State of Emergency due to the corona virus pandemic.

The Board of Overseers met at 10:00 AM at the Freeport Public Safety Building on Saturday, March 14, 2020. Overseers present were: Tanya **Sweatt** – Chair, Hank **Rauch** - Vice Chair, Judy **Hayes**, and Craig **Allard**. Other officers/appointees/contractors present were Sue **Spalding**, Clerk; Tony **DeBruyn**, Treasurer, and Crawford and Candy **Taisey** of Straight Edge Construction, Superintendent.

**1. MINUTES. On a motion made** and seconded it was **VOTED** 4-0 to approve the minutes of the February 5, 2020 Board meeting.

#### 2. PUBLIC COMMENTS

- An islander suggested that we keep Narcan at the First Aid Room. A review of consultation with Dr. Dave Dickison revisited the problematic issues involved with doing so.
- An islander requested that the Pidges Cove stairs be inspected for safety. Crawford will do this.

- **a. On a motion made** and seconded it was **VOTED** 4-0 to approve the "2020 Lilly B. Schedule and Fares, v. 1.3"
  - The five-year Coast Guard Inspection of the Lily B. is due this year
  - There are far too many packages being sent to Bustins through USPS for the captains to be handling. BAC will address this issue and make recommendations.
- **b.** COVID 19 (corona virus) preparedness the BIVC will be following state recommendations.
