The Board of Overseers met at 10:02 AM via ZOOM virtual meeting on Saturday, April 4, 2020. Overseers present were: Tanya **Sweatt** – Chair, Hank **Rauch** - Vice Chair, Judy **Hayes**, Craig **Allard**, and Mandy **Meyer**. Other officers/appointees/contractors present were Sue **Spalding**, Clerk; Tony **DeBruyn**, Treasurer, and Crawford and Candy **Taisey** of Straight Edge Construction, Superintendent. 23 islanders attended via ZOOM.

1. MINUTES. On a motion made and seconded it was **VOTED 4-0:** Tanya-yes, Hank-yes, Judy-yes, Craig-yes, Mandy-abstain (she was not present at that meeting), to approve the minutes of the March 14, 2020 Board meeting.

c. COVID 19 Preparedness/Response/Communications to islanders
At length the Board reviewed the chair's draft of the Bustins Island
Coronavirus Response for distribution to islanders, for which Tanya had
done much research of federal, state, and local conditions and readiness.

In discussion it was noted that some island services are linked to the ferry and employment, e.g. wells, honey wagon, trash. Other restrictions are consistent with federal and state mandates and recommendations.

On a motion made and seconded it was VOTED 4-0: Tanya-yes, Hank-yes, Judy-yes, Craig-yes, to authorize the release of the Bustins Island Coronavirus Response as amended.

It will be sent via email, Facebook, bivc.net and posted on the island and at the South Freeport dock. The document will be updated and distributed as information changes.

Employment issues were discussed: how to maintain Abe, Matthew, Dan Adams, and boat hourly crew and captains to the extent that we can be prepared. Everything is on pause right now as information changes rapidly. We want to be prepared to start the Lilly B. as soon as it is possible, and will start work on her as soon as Brewer's opens.

- **b.** New business Craig reported extreme difficulty in contacting Maine Island Energy regarding the need to have a regulator in order to have gas.
