# Final (as of 11/17/07) Minutes of the Board of Overseers meeting held October 7, 2007 - 9:00 AM

Brewer Cottage, Bustins Island, ME

The Board of Overseers met at 9:00 am at the Brewer Cottage, Bustins Island, Freeport, ME on Sunday, October 7, 2007. Those present were: Tony **DeBruyn**, Chair; Pat **LaFleur**, Vice Chair; Bill **Roberts**, Roger **Leland**, Sue **Spalding**, Clerk; Diane **Jellis**, Secretary; and Charlie **Johnson** (MS/S). Also present for the meeting: Lorraine Leland. Absent: Scott **Bonney** and John **Garfield**, **Treas**. The Chairman declared a quorum as four members of the Board were present.

#### 1. Minutes

## 5. Maintenance Supervisor/Superintendent (MS/S) Report – Charlie Johnson

- a. Steamer Dock Last improvements mad 13 years ago
  - 1) Prock came and looked at pins and concrete and pilings. Estimate \$7,880 to repair. This would be preventative maintenance from ice and storm damage. Can do it this fall. Charlie recommends repairs.

- 2) **ACTION:** A motion was made (Leland), seconded (DeBruyn), and passed unanimously to authorize Prock to do necessary repairs to steamer dock as quoted in their estimate dated September 14, 2007 as preventative maintenance in the amount of \$7,880.00.
- b. Tractor Damage Hood and grill are broken. Rob Taisey will take hood and repair. There is a grill and brush guard that includes non-working headlights. CJ will not replace this year but needs to be done in the future.
- c. Discussion re accumulation of brush
- d. Discussion re the fact that some islanders still bury outhouse waste on other's land. If this is a problem the neighbor whose land is being used as the burial site needs to send a complaint to the BOO.
- e. Discussion re "For Sale" signs cropping up around the island for bric-a-brac
- f. J. Carrier, III resigned as Fire Chief. Board would like a letter of resignation.

- h. Lilly B out October 15 and stored at Brewers
- i. Store well retested satisfactory on September 20, 2007

#### 6. Other Business

- a. Drainage Final Cudlitz report dated 9/19/07 came in/it is voluminous. Lionel Plante Assoc. received a copy also. No one has read it yet. Martens still want to do the temporary fix before winter. Pat LaFleur and Tony DeBruyn told the Martens to go ahead with the temporary fix that was suggested at the September BIVC meeting.
  - 1) Implementation of temporary fix is of no cost to the island
  - 2) BOO will read the report and further discuss it at their November 17 meeting.
- b. Discussion re Deer Hunting from Sue re what has happened in the past. There is no reason to give permission to hunt based solely on concerns re deer population and Lyme disease.
  - 1) **ACTION: A motion was made** (LaFleur), seconded (DeBruyn), and passed unanimously to approve Ron Tozier's request to bow hunt on Bustins Island according to Maine State Law
