Minutes of the May 26, 2013 Meeting

The meeting was held at the Community House, Bustins Island, Freeport, Maine. Present were Chair, Christine Martens, Vice Chair, Dave Gosnell, Dave Guernsey, Charlotte Kahn, Warren Barrows, Secretary, Jeff Leland, and Associate member, Kevin Petrie. Bustins Island Board of Overseers member, Bill Cooper, attended for the first half hour. Absent was CEO Ron Tozier. The meeting was called to order at 8:30 a.m.

#### 1. Road Update

Presentation was made by Bill Cooper. He indicated that there is nothing new. It is the intention of the Planning Board to bring forward to the Annual Meeting the so-called "Golf Course Road" or suggested name of, "Middle Road" and possibly a section in front of Lois Dennett's property that was widened in 1994.

# 2. Zoning Ordinance Revisions for 2013

A presentation was made by Warren Barrows regarding numerous proposed Warrant Articles. It is part of the Planning Board's ongoing project to clarify and improve the ordinance. Discussion followed. It was determined that approximately six to ten Articles that will include basic corrections to capitalization and defining certain terms within the Code, as well as one or more substantive corrections, will be brought forward this year. A motion was duly moved, seconded, and unanimously approved to send seven Warrant Articles designated 1, 2, 3, 4, and A, B, and C as presented with corrections.

## 3. CEO/LPI Status Report

CEO was absent due to weather. Thus far there are no CUP hearings scheduled this summer, so there is nothing to report.

### 4. Approval of Minutes

Upon a motion duly moved and seconded the April 27, 2013 meeting minutes were unanimously approved as submitted.

Charlotte Kahn and Dave Gosnell presented the status of the Comprehensive Plan. A discussion ensued relative to the present situation, prior history, and timeframe for action to take place this summer.

#### To Do List:

- 1. Ron Tozier will check to see if there is any liability if residents making improvements or renovations to their electrical system are not required to obtain a State inspection.
- 2. Ron Tozier to create a list of licensed electricians on the Island that can be made available to Islanders who wish to have their systems inspected or upgraded.
- 3. Ron Tozier will look into grants for mitigations for climate and erosion issues.
- 4. Dave Gosnell and Charlotte Kahn to ask someone about the grant writing process.
- 5. Dave Gosnell and Charlotte Kahn will draft wording for Comprehensive Plan Warrant Article by June 1, 2013.
- 6. Dave Gosnell will ask Ron Tozier about removing hazardous trees.

#### **Long-Term Agenda Items:**

- Continue to (i) investigate and identify BIVC coastal roads and property at risk of loss due to erosion from existing or projected increase in sea level and storm activity and intensity, and (ii) possible need for professional study of coastal bluffs to determine whether action is warranted, and if so, available options.
