- 3. The Public Float and Steamer Dock will need refastening/repair work in the next few years.

- A. Grant Submission
 - 1. Ken awaits notification about the grant award.
- B. Safety Procedures
 - 1. Ken, Bob, and Ali are going to visit the 911 dispatch center on July 7 to discuss various Island-related scenarios.
 - 2. A summary from the meeting will be shared with Islanders on July 12 during Safety Day.

C. Chipping Update

- 1. Chipping Day is confirmed for July 17, 2025.
- 2. Forms have been placed in the Post Office lobby for pickup and return.
- 3. Ken would like to receive forms two weeks in advance (by July 3). Forms can be printed in the Schoolhouse and returned to Ken in-person or via email.

D. Starlink

- 1. Starlink was down last week and replacement parts are en route.
- E. Well Schedule
 - 1. The public well schedule was posted this past week.
- F. Voting List for Annual Meeting
 - 1. Bob and Ken will contact Sue about this.

VII. Superintendent Report

- A. Firehouse Barn
 - 1. The skylights need to be replaced.
 - a) Some batteries have been donated to Bustins that could be used to install lighting instead of putting in new skylights.
 - 2. A contractor will visit the island to provide a quote for new garage doors

and tracking.

- B. Library/PO/Nature Center/Museum Underpinnings
 - 1. It is now dry enough to go underneath with equipment if needed.
 - 2. Phil said that Ben said it was in decent shape as of a few years ago, but another review should take place.
 - 3. Phil will research drainage options as the overall area is very wet. A network of drains is needed.
 - a) A CUP hearing would be required.
 - b) BOO could hire a contractor or conduct the project on its own with Islander equipment.
 - c) There is one drain down there installed by Bud Nickerson but more are needed.
 - d) This project could be at odds with the arguments that wish to maintain the Bustins water table.

C. Agreements and Forms

- 1. The Code Enforcement Agreements have been signed and Phil will bring the documents back to Bustins.
- 2. Phil will scan and send them back to Shannon.

D. Roads

- 1. Phil will continue to patch up puddles and control water when it rains.
- 2. Some cars are moving quickly on roads that affect road quality and safety.
 - a) Phil will speak to drivers directly and Ken will send an email to all vehicle users.
